

# City of Reedsburg Meeting of the Common Council

## March 24, 2014

Mayor Estes called the regular session of the Common Council to order at 7:00pm in the Common Council Chambers.

Mayor Estes thanked Kent Stone for 12 years of service and good luck in his retirement from the Public Works Department.

**Moved by Craker and seconded by Finnegan to approve the consent agenda, consisting of Minutes from the Council meeting held on March 10, 2014; Mayor appointment of Mark Hoof to the Community Development Block Grant Committee to fill a vacant term expiring April 2016; Special Event Permit for the RRO on April 19<sup>th</sup> from 10am to 2pm for Family Fun Day at City Park, waiver of fees requested; Special Event Permit for the RRO on July 25<sup>th</sup> from Noon to 10pm for Redikulas Days at City Park, waiver of fees requested; Temporary Class “B”/”Class B” Retailers License for RRO Reedsburg Uncorked Wine Walk on April 25<sup>th</sup> from 6-9pm at 20 downtown locations; Operator Licenses for Amy Campbell and Sabrina Dietz. Motion carried 8-0.**

Public hearing was held on Ordinance 1790-14 correcting sections of Chapter 38 on enforcement and penalties for sex offender violations. No public comments. **Moved by Heuer and seconded by Moon to approve Ordinance 1790-14. Motion carried 8-0 on a roll call vote.**

**Moved by Glick and seconded by Knudsen to write off \$74.11 of delinquent personal property taxes from 2012. Motion carried 8-0.**

**Moved by Werner and seconded by Craker to approve curb & gutter low bids of \$70,081.40 by Rennhack Construction for Contract A and \$8,900 by Schloughs Classic Concrete & Construction for Contract B. Motion carried 8-0.**

**Moved by Heuer and seconded by Glick to approve crushed aggregate base course low bid of \$60,416 by Ray Zobel and Sons. Motion carried 8-0.**

**Moved by Knudsen and seconded by Cowan to approve equipment rental low bid of \$145/hr for backhoe and \$85/hr for tri-axle dump truck by Ray Zobel and Sons. Motion carried 8-0.**

**Moved by Heuer and seconded by Glick to approve Resolution 4206-14 ordering the repair and installation of sidewalks on various streets in area F of the City. Motion carried 8-0.**

**Moved by Craker and seconded by Finnegan to approve 2014 nuisance abatement low bid of \$40/hr for weed mowing and junk removal by Horkan Construction. Motion carried 8-0.**

**Moved by Glick and seconded by Craker to adjourn. Motion carried 8-0. Meeting adjourned at 7:16pm.**
