

City of Reedsburg Meeting of the Common Council

May 11, 2015

Mayor Dave Estes called the regular session of the Common Council to order at 7:00pm in the Common Council Chambers.

Mayor Estes introduced Abby Voigt, the winner of the 4th grade Future Mayor election. Abby assisted the Mayor in running the meeting.

Mayor Estes swore in new police officer Amanda Georgeson.

Mayor Estes presented certificates of appreciate to Evelyn Skinner and Roger Friede, Sr. for years of service on the Industrial Development Commission.

Mayor Estes read Proclamation in Recognition of Drowning Prevention Month.

Moved by Heuer and seconded by Craker to approve the consent agenda, consisting of Minutes from the Council meeting held on April 27, 2015; Temporary Class “B”/”Class B” Retailers Licenses for Reedsburg Home Talent Baseball in Nishan Park for home baseball games in May, June and July, for Reedsburg Jaycess on June 16-21 for Butterfest and on November 7th for Hunters Night Out in Nishan Park; Operator License for Frederick Burdick; cancelation of City Council meeting on May 25th; Mayor appointments of Mike Glick to Utility Commission, Tiffany Schulte to Personnel Committee and Todd Polk to the Board of Review. Motion carried 8-0 with Alderperson Schulte abstaining.

Public hearing on Ordinance 1802-15 creating Section 17.12 Schedule 5 Resource Conservancy and Government Zoning District. No public comments. Ordinance creates separate zoning district for government owned properties. **Moved by Peterson and seconded by Schulte to adopt Ordinance 1802-15. Motion carried on a roll call vote 9-0.**

Moved by Werner and seconded by Cowan to approve Certified Survey Map for E7020 Labansky Road, combining parcels 030-1166 & 1167 in the Town of Reedsburg. Motion carried 9-0.

Moved by Heuer and seconded by Craker to set public hearing date of June 8, 2015 for Ordinance 1803-15 updating purpose of Rescue Fund in Section 5.16(1).

Moved by Moon and seconded by Finnegan to set public hearing date of June 8, 2015 for Ordinance 1804-15 repealing non-council term limits in Section 2.01(3).

Moved by Moon and seconded by Werner to set public hearing date of June 8, 2015 for Ordinance 1805-15 repealing weights and measurers permit and fees in Section 12.13(4) to 12.13(8).

Ethics code was reviewed.

Moved by Craker and seconded by Heuer to adjourn. Motion carried 9-0. Meeting adjourned at 7:24pm.
