**Narrative**

On the above date and time, I responded to the above location for a minor crash. I made contact with the RP, Tim Becker. Becker advised he had witnessed Olson's vehicle traveling at a high rate of speed, darting in and out of traffic. Becker stated it appeared as though Olson was running late for work. Becker advised that Weigand's vehicle slowed to wait for a truck towing a boat to negotiate a right turn. Olson's vehicle struck Weigand's vehicle from behind. Weigand confirmed she had slowed for a vehicle negotiating a right turn before she was struck.

I spoke with Olson. He stated that he changed lanes and observed Weigand's vehicle slow down. Olson stated he tried to stop in time, but was too late and he struck the rear end of Weigand's vehicle with the front bumper of his vehicle. I asked Olson if he was following the vehicle too closely to stop. Olson replied "yes." I advised Olson to contact his mother, Jennifer Olson, but he was unsuccessful. I advised Olson he would be receiving a citation by mail.

I examined both vehicles and found paint transfer and a small crack on Weigand's rear bumper and I could locate no apparent new damage to Olson's vehicle due to its condition. Olson stated the vehicle had front bumper damage when he bought it. Photos were taken of the damage and areas of collision. I checked with both parties for injuries and neither reported any injuries. Information was exchanged and I cleared from the call.
