Narrative

Unit two was traveling westbound on East Main Street onto Viking Drive. Unit one was following unit two and also turned off of East Main Street onto Viking Drive traveling northbound. Unit one turned into the inside lane instead of the outside lane when she made the turn onto Viking Drive. Unit one traveled alongside Unit two as unit two was traveling in the outside lane going Northbound on Viking Drive. Unit two attempted to change lanes into the inside lane to turn into a business on the Westside of Viking Drive but Unit two failed to check his blind spot before switching lanes which resulted in him striking the passenger side of unit ones vehicle. It should be noted no injuries were reported or claimed during this incident.
