For Check Payments

- Make checks payable to:
City of Reedsburg Treasurer
- Include parcel number on the check
- Include phone number on check, for questions
- Include payment stub from the tax bill
- Endorsement on back of escrow checks only: - If there are multiple names on the "Payable To:" line - all parties must sign the back of the check before submitting to City of Reedsburg
- If paying by mail or drop box and you would like a receipt, please include a self-addressed, stamped envelope

Credit Card Payments

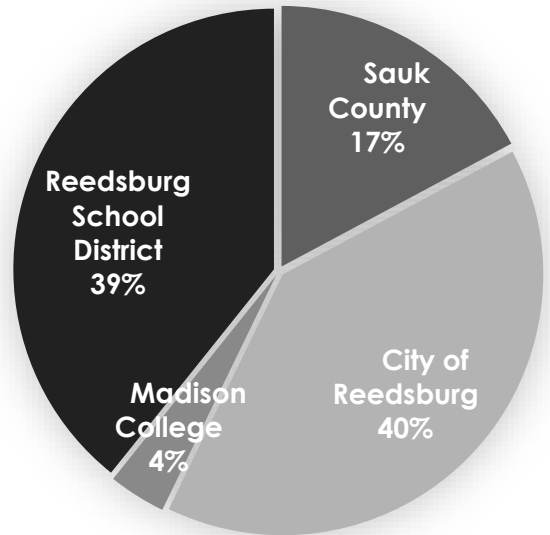

Refunds

If your escrow check exceeds the amount due for your taxes, a refund will be issued to the name and address of the homeowner on the tax bill. The refund will be issued within 30 days.

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible!

To Qualify: Your home must have been the **PRIMARY** residence for you or the previous owner on January 1, 2024. If you feel you qualify for the Lottery Credit: You may obtain the Lottery Credit Claim Form by contacting the Treasurer's Office at 134 S. Locust St., or call 608-524-6404, prior to January 31, 2025.

AM I ELIGIBLE FOR THE FIRST DOLLAR CREDIT?

If your real estate bill has an "assessed value improvement" amount, the credit should automatically show on your bill. Anyone entitled to the credit that did not receive it must appeal directly to the Wisconsin Department of Revenue at 608-266-2486.

Dog Licenses

Per section 210-5 of the City Code, dogs and cats living in the City must be licensed for the year beginning on January 1st and ending on December 31st. Any dog or cat over five (5) MONTHS of age are required to be licensed prior to March 31st of each year. Please stop at City Hall to pick up your licenses and provide a valid rabies vaccination certificate.
